3. Presentation by Ms. Carol O'Reilly, Dept. of Tourism, Transport and Sport:

Ms. Carol O'Reilly, Dept. of Tourism, Transport and Sport provided a detailed presentation. The Department were reviewing their Sustainable Mobility Policy and the presentation was part of that process. The Assembly were encouraged to make a submission by the closing date of 28th February.

Key issues discussed included:

- The a lack of bus shelters which should be addressed at the policy level;
- Ease of access for public to get to public transport;
- Need for continuous cycle lanes required in all areas.;
- Lack of taxis in rural areas and difficultly in obtaining new taxi licences in rural areas.
- Possibility of returning to concrete footpaths as flag paths are causing safety issues and rise in claims for LA.
- Possibility of services such as Uber being rolled out in rural areas.

Mr. David Kelly, thanked Ms. O'Reilly for a very detailed and informative presentation and confirmed that the Assembly will be making a detailed submission to Dept. of Tourism, Transport and Sport.
